SUBJECT: 2016-2022 CARPENTERS SAN DIEGO MASTER LABOR AGREEMENT

Effective July 1, 2021, in accordance with the Carpenters Master Labor Agreement, there will be \$2.00 increase to be allocated as follows:

Supplemental Dues	\$0.07
Annuity	\$1.00 (Beginning at 3 rd Period)
