SUBJECT: 2022-2026 CARPENTERS MASTER LABOR AGREEMENT
11 COUNTIES OF SOUTHERN CALIFORNIA

Effective July 1, 2022, in accordance with the Carpenters Master Labor Agreement, there will be \$3.00 increase to be allocated as follows:

Apprenticeship	\$0.05
